Baruah Road, Guwahati** within 01-07-2026 (Medical Certificate format is enclosed as Annexure-B), the cost of which is to be borne by the candidate concerned.

Please note that the offer of appointment shall be issued upon successful completion of pre-joining formalities only.

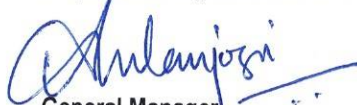
It may please be noted that candidates should come well prepared on the day of Photo, Biometrics/Iris & Document verification/Pre- Joining formalities with the following documents/certificates in original along with the self-attested photocopies of the same:

1. Print out of the original e-mail / notice sent by IBPS, Mumbai or e-mail sent by Bank intimating about one's allotment to Assam Gramin Bank for offer of appointment in the post concerned.
2. Acknowledgement/Money Receipt of Medical Test at Apollo Medical Centre.
3. Print-out of the filled-in application form with photograph, duly signed.
4. Secondary School Certificate/School leaving certificate for proof of age.
5. Mark sheet (Year/Semester wise) showing specifically the subjects studied including the local language of the state and certificates in support of educational qualification viz. SSC/HSC/Graduation/Post graduation/ Professional/Research qualification/Experience etc.
6. Caste certificate from the Competent Authority in prescribed format in case of candidates belonging to SC/ST/OBC (Non-Creamy Layer)/EWS. The caste/tribe, for which reservation is claimed, must be in the list of scheduled caste/tribe, OBC, as notified by Government.
7. Certificate of Disability issued in the prescribed format by the Medical Board of at least three doctors constituted by the Government clearly specifying the category and degree of disability, in case of differently-abled persons.
8. Discharge Certificate/Proforma-A for Released/Retired Personnel as per format of IBPS, in case of candidates serving in the Defense Services.
9. Photo Identity proof and Address proof.
10. Police verification report for place of domicile and criminal record (within 3 months of joining).
11. Unconditional and satisfactory discharge/release certificate from present employer, in case of candidates already employed. No lien or quasi-lien service will be accepted.
12. Four copies passport size (4cm x 3cm) and one copy postcard size (15cm x 10cm) of color photograph similar to that submitted at the time of CRP RRBs XIV, signed on the back by a ball pen and name written thereon.
13. Any other relevant document.
14. Candidates may also approach Apollo Medical Centre Authority for earlier medical health checkup as per convenience of Apollo Medical Centre Authority (**contact details 7577005558 / 9706926298**).

Other documents to be submitted:

1. The candidates are required to execute an Indemnity Bond on a non-judicial stamp paper of Rs.1000/- only for continuing of minimum of three years of service, failing which an amount of Rs.1,50,000.00 (Rupees One Lakh Fifty Thousand) with interest equivalent to Bank's prevailing MCLR, from the date of breach of the conditions of agreement till payment must be made, apart from giving the employer Bank a three months/one month' notice (as per Service Regulations of the Bank) intimating his/her intention to resign from the service of the Bank. **For this purpose, one "Surety" (preferably natural guardian) must accompany the candidate for signing and execution of the bond on the day of pre joining formalities along with KYC documents of the "Surety" in original and photocopy as well.** All candidates should come with the indemnity bond duly typed in stamp paper which will be executed on above date. **Non judicial stamp paper of the state of Assam, without notarization and purchased in the name of the candidate (1st party and Bank as 2nd party) will only be acceptable.**

All other formats (a) **Declaration of Fidelity and Secrecy**, (b) **Declaration of Marital status** (c) **Declaration of Domicile** (d) **Declaration in respect of Service Regulations** (e) **Format of Bio-data**, (f) **Application for Digital I-Card**, (g) **Format of Specimen signature** as enclosed should be completely filled up before attending the pre joining formalities.
